### **CPTNB Membership Categories, Codes and Fees**

Subject to change without notice

- The application fee is non-refundable once it has been received by CPTNB
- Once you have been registered, there are no reimbursements of practising fees, regardless of when/if you stop practice in N.B. during the year.
- Payment must be by cheque or money order only, payable to CPTNB
- On the Application form indicate the appropriate Registration code at Q1 and the Membership Code at Q2
- Download the application information kit matching your Membership category

# Membership (Q2) - Code 01 Practising Member

For members who qualify for unrestricted certificates to practise, and includes applicants who are:

**Transfers** (also concurrent) (Q1-04), **Reinstatements** (Q1-02) and possibly **Recent Graduates** (Q1-03) if you are a recent graduate who has completed the PCE process before applying to CPTNB.

**FEE = \$400.** any practice before July 1st **PLUS** Application Fee of **\$150.** 

Total = \$550.

OR \$275. if practice starts July 1st or later, PLUS Application Fee of \$150.

Total = \$425.

## Membership (Q2) - Code 06 Practising Provisional

For members whose certificates to practise have terms, conditions or limitations applied, and includes applicants who are **recent graduates** and others undergoing exams and assessments.

**FEE - Group 1 = \$400.** any practice before July 1st **PLUS** Application Fee of **\$150.** 

Total = \$550.

OR \$275. if practice starts July 1st or later PLUS Application Fee of \$150.

Total = \$425.

FEE - Group 2 (for QC Graduates only, who are not already registered in Quebec) Contact Registrar If you are a QC graduate already registered in QC, apply as Group 1

#### Membership (Q2) - Code 02 Not Practising

FEE = \$100.

For members who were registered as active with CPTNB in the previous year *and* who are not actively engaged in the practice of physiotherapy anywhere *and* who remain eligible for re-instatement. (e.g. parental leaves) If you are registered in another jurisdiction, this category does not apply to you. You may apply for concurrent *active* registration with CPTNB as long as you meet the application requirements for active registration.

IMPORTANT: Members who register as Not Practising/Inactive and who wish to return to active practice during the same year, must register for active practice by **paying the balance of the practising fee**, **providing proof of current individual PLI** and having **confirmation of being registered as active** BEFORE returning to practice. Apply to CPTNB at least 2-3 before start date.

Additional fees = \$300. if practice begins before July 1st OR \$175. if practice begins on or after July 1st

#### Membership (Q2) - Code 03 Temporary/Telepractice

FEE = \$125.

For members whose certificates to practise are time, event or situation limited and who <u>concurrently maintain registration in good standing in another jurisdiction</u> during the duration of the temporary practice in N.B. in any one year, to a maximum of 30 days.

#### Membership (Q2) - Code 07 Retired

FEE = \$100.

For members whose practice hours have fallen below minimum (1200/5 yrs.) but who may use the title in certain circumstances. *Read Regulation 2 and contact the Registrar*. You may be eligible for this category if you are no longer employed in field for which your Physiotherapy background was required to obtain the position. If you are in a position where registration as a "PT" or use of the title is referenced, you must qualify for active registration.
